The 12-month full-time Master of Real Estate and Infrastructure (MREI) is designed to prepare students for long-term career success in the business of real estate and infrastructure. The program will combine theory with practice, focus on the personal growth of its students and connect them to a dynamic network of alumni and industry players.

**The MREI is the first graduate program in Canada that offers courses in both real estate and infrastructure.** It will build on the reputation and experience of Schulich's existing MBA specialization in real estate and infrastructure, founded in 1991. Our goal is to develop future leaders in real estate and infrastructure development, investment, finance and operations.



## A FOUNDATION BUILT UPON REAL WORLD EXPERIENCES

The Schulich MREI experience will be enriched by an extensive program of co-curricular activities including case competitions, networking events, industry conferences, specialized training, field trips and study tours. Students of the program and alumni of the MBA specialization in real estate and infrastructure will be involved in organizing and coordinating much of the co-curricular program.

## BUILD YOUR CAREER IN UNDER 12 MONTHS

Students of the MREI will take a common set of courses in the first two terms with the option to take either real estate or infrastructure electives in the third and final term. The program also offers an optional internship in Term 3 with a lighter course load and classes scheduled on evenings and weekends.

The backbone of the curriculum is a leadership development course that runs throughout the three terms and serves as a vehicle to integrate learning from every aspect of the student experience.

The MREI is offered on a full-time basis only. Each student must complete 42 credits: 36 required credits + 6 elective credits.

# ADMISSION REQUIREMENTS



**An undergraduate degree from a recognized university with a minimum B average in the last two full years (or equivalent) of academic work.**



**Proof of English language proficiency if studies were not completed in English:**

Accepted Tests    Minimum Score

IELTS ..... 7.0 overall

TOEFL..... 100 iBT

YELT ..... Band 1



**GMAT or GRE**

An acceptable score on the Graduate Management Admission Test (GMAT) or Graduate Record Examinations (GRE).



**Work Experience**

Relevant full-time work experience of 2-5 years is strongly preferred.



**Completion of the Online Application**

To apply, you must complete and submit the online application. Please note: there is a non-refundable application fee of \$150. The following must be submitted as part of the process:

- A completed application form
- Statement of Interest
- Video essays
- Two recommendations (at least one academic)
- A resume
- Official GMAT or GRE score
- Official transcripts from all post-secondary institutions attended
- Proof of English language proficiency (if required)
