# Bachelor exchange – course offer 2023-2024 (under regular reservation)

# BSc courses, minors, electives & modules from tracks

Visiting exchange students can enroll in courses from all three Bachelor years of our BSc International Business Administration programme. Almost all 1<sup>st</sup> and 2<sup>nd</sup> year courses open to exchange students offer enough spots to allocate all students. In the 3<sup>rd</sup> year courses and some of the other courses, spots may be limited and allocated mostly on first-come, first-served basis.

# **Exchange Fall term**

The fall term offers courses in the following blocks in all three Bachelor years:

1 <sup>st</sup> Bachelor year:	block 1 and block 2
2 <sup>nd</sup> Bachelor year:	block 5 and block 6
3 <sup>rd</sup> Bachelor year:	block 9 and block 10

Courses in blocks 1, 5 and 9 are offered in the first half of the fall term (September-October/November) and courses in blocks 2, 6 and 10 are offered in the second half of the fall term (October-December). Courses from different Bachelor years can have an overlap in the timetables. All students are required to participate in the **full** fall term. Therefore, all students need to participate in (atleast) one course in the first half of the fall term.

### Workload requirements

In the fall term, students need to obtain a minimum of 20 EC in total. The maximum number of credits for the fall term is 30 EC, although we strongly advise not to surpass 24 EC. Only the credits of passed courses count towards this minimum requirement.

## **RSM fall electives**

In the 3<sup>rd</sup> Bachelor year curriculum, we offer 4 electives in the fall term of which 2 are online. These courses are also open to incoming exchange students. However, there are limited spots available, so students must apply in time. Students can participate in only 1 elective; they may rank up to 3 preferences in total when applying for an elective.

# **RSM fall minors**

Minor courses are offered in the fall term only and have a workload of 15 EC. This is because a minor is a combination of 2-3 courses that specialize in one subject. As it is one course, there is no subdivision of the credits possible. It is comparable to a major, only smaller in size and workload. More information on the content of minors can be found at <u>minors</u>. In the search bar, enter the name of one of the minors mentioned below to find more information. Please ignore the option for the FAQ and the dates mentioned at "Register between" en "Enrolment" as this information is not applicable to exchange students. Students can only participate in one minor; they may rank up to 3 preferences in total when applying for a

minor. As spots are limited, students need to apply in time.

# Exchange periods

In the spring term, we are offering 7 different exchange options. Each exchange option has a different starting and/or ending date, with different minimum required workloads. With this extended offer, we hope to fit most student's requests for periods of stay during their exchange. In case of courses at their home university in January, they can start later and in case of internships or other obligations, they can end earlier.

We do request students to participate in courses throughout the entire period of stay. It is not allowed to have a period of more than 1 week without participating in courses.

Exchange periods are indicated by the partner universities upon nomination of their students. We also ask the partner universities if their students are allowed to select a different exchange period. This way, if they do, we can just proceed with their application without having to first check with the partners and delay the process.. The course registration will take place in different stages, starting with the courses that are offered at the start of the spring term.

There are 5 tracks in total that allow students to follow their field(s) of interest and to prepare for a master. Exchange students can choose to participate in modules from different tracks, provided they are sequential. E.g., they can participate in module 2 from the track "Performance Analysts" and in the next block, participate in module 3 from the track "Global Thinkers'.

Students cannot participate in more than one module per block due to overlaps in the timetables.

**IMPORTANT NOTE**: For Track 1 (Analytical Decision-makers), it has been decided that due to the structure of the modules, students can only participate in module 2 if they have participated in module 1, and can only participate in module 3 if they have participated in modules 1 and 2.

# Additional information RSM courses

#### Course guide

Students can find information on the courses in the <u>course catalogue</u>. Just type in the course code of the course concerned to be directed to the information. We aim to have all updated information published about two months prior to the start of the courses. Until the updated information is available, students can check information from the year before.

#### Course manuals & timetables

The course manuals will be published about 1-2 weeks prior to the start of the courses. We aim to publish the new timetables around mid-July. These will be published on the platform Canvas and are only available to students enrolled in the course concerned.

The timetables will also be published around mid-July via MyTimetable. Students will have to login to get access to the timetable information. The link to MyTimetable will be shared before the new timetables are published.

#### Course registration

Nominated students will receive information from the International Office on how and when to register. Some of the information on courses and registrations provided on the regular online channels for students may vary for exchange students. The International Office will inform students further on this.

#### Class schedule / exam registration

It is the students' own responsibility to ensure that the schedules of their selected courses do not have overlaps. This also applies to exams and re-sits.

Once enrolled in a course, the student is automatically registered for the regular exam. If a student fails a course, they will be automatically registered for the re-sit. More information and instructions on re-sit registration are passed on to the students in due time.

### **Courses at other faculties**

Next to the RSM courses, students can also participate in a course from some of the other faculties of the Erasmus University Rotterdam. The faculties that accept our students are the Erasmus School of History, Culture and Communication (ESHCC, including IBCoM) and the Erasmus School of Social and Behavioural Sciences (ESSB). The information and registration of their courses go directly via the faculties. Exchange students will receive information on how to contact these faculties.

Some of the other faculties may also accept our students after a request from the student. E.g., the Erasmus University College (EUC) also offers a few courses in which they accept some of our students. Please note though, that spots are very limited at EUC, and this faculty is not on campus, but in the city centre of Rotterdam. The Erasmus School of Economics is <u>not</u> accepting RSM exchange students in their courses.

Keep in mind that most credits during the exchange must be taken in RSM courses. We will provide the links to the webpages of ESHCC and ESSB courses well in time before the registration starts for their courses.
