- Registration fee of \$100 CAD per team via secure payment ٠ on registration page.
- No refunds will be issued after your team is fully registered ٠ and the registration period has ended.
- Team member substitutions Up to one team member may be substituted prior to closing of registration.
- Anonymity Random team numbers will be assigned-٠ teams may not identify their names in submission material.

- · The title slide should only show the team number, no individual names, or any use of slide backgrounds or formats that might make it possible to identify the team members may be included in any of the slides.
- Submission email subject "DDXIV Team #" only.
- No changes to the presentation are allowed after • submission. Same presentation will have to be used for Semi-Final and Final rounds.

• The Semi-Final and Final Rounds will take place inperson on **9 May 2024** in Toronto.

SEMI-FINAL ROUND

- The qualifying teams will be divided into three groups.
- Each team will present its slide deck to a panel of Semi-Final round judges, made up of senior professional developers and investors.
- There will be one panel of judges assigned to each group of three to four teams.
- At the conclusion of the Semi-Final Round, each panel will select one team to advance to the Final Round.
- Teams will receive their presentation time at the start of the day.

FINAL ROUND

• During the Final round, the three finalists will present their slide decks to the Developers' Den judging panel, which will be comprised of senior professional developers, investors and executives.

CASE COMPETITION | RULES

RULES

- Students are required to maintain the highest standards of academic honesty throughout this competition and to abide by the rules and procedures outlined herein. The organizers of the event reserve the right to make modifications and/or clarifications to these rules prior to the competition. Teams that fail to comply with the rules will be disqualified.
- Dress code is business attire.
- A minimum of two of three team members, depending on the size of your team, must attend the competition in order to compete. All competing team members must be present and participate in both the Semi-Final and Final presentations if successful.
- Teams may not seek advice or information or otherwise consult with any third party (including the sponsoring faculty member) at any time throughout the competition.
- Internet access is permitted, and use of publicly available information found on the internet is allowed.
- Slide decks must include a title slide showing only the team number. No individual or institutional names, or any use of slide backgrounds or formats that might make it possible to identify the team members or the School that they represent may be included in any of the slides.
- Slide decks are limited to a maximum of 11 slides including the title slide.





CASE COMPETITION | RULES

RULES (CONTINUED)

- Slide decks must be submitted by 5:00 pm on 6 MAY 2024 to the email address identified by the organizers.
- The order in which teams present will be determined randomly.
- Times and locations for Semi-Final round presentations will be provided at the start of the day.
- The Semi-Finalist teams must be outside of the presentation room at least ten minutes before their scheduled presentation times.
- The names of the three finalist teams will <u>**not**</u> be announced in advance.
- All Semi-Finalist teams should congregate at the venue at **5:00 pm** for the final round presentations.
- The selected three teams will be invited by the organizers to present impromptu for the Final Round presentations.
- Each presenting team, in both the Semi-Final and Final Rounds, will have up to twenty minutes to present its recommendations : up to ten minutes for an initial uninterrupted presentation and the remaining time for Q&A with the judges.
- No changes to the slides are permitted after they have been submitted by email on 6 MAY 2024.
- In the event that an interpretation of the rules is required, the decision of the organizers will be final.
