Visa

Staying for less than 90 days

A Short Term Residence Visa (C-3) is required and is good for only 90 days, no extension is allowed. Students from visa-waiver countries are not required to obtain a visa if staying under 90 days.

Staying for 90 days or more (Recommended for Exchange students)

A Student Visa (D-2) is required. For detailed instructions and requirements, please consult your local Korean Embassy or Consulate. Yonsei will provide the Certificate of Enrollment and the Certificate of Business Registration, which are two essential documents for visa application.

Also, Students staying for more than 90 days in Korea must apply for the Alien Registration Card (ARC) within 30 days from the day of arrival to Korea.

(*) Please note that as of February 2021, no foreign national can enter Korea without a valid immigration status(a visa), even if s/he is from a visa-waiver country. This measure is closely related to the COVID-19 situation both in and outside of Korea and is subject to change. Please consult your nearest Korean Consulate for the most up-to-date information.

Health Insurance

All incoming exchange & visiting students are obligated to obtain personal health insurance. Please enroll in a health insurance plan of your choice, as there is no designated insurance service provider but it is recommended that you choose a study abroad plan which will cover medical expenses to be incurred during your exchange in Korea. Mandatory insurance plans provided at your home institution will be sufficient, but proof (an official letter) must be provided. The proof of health insurance should include the name of the insured, period, and place of coverage. Student will have to pay the full fee up front, and then apply to his/her home insurance company for some form of reimbursement.
