Academic & Administrative Information

Teaching Methods

A variety of methods, including lectures, case studies, presentations, project work, computer-based business games, multimedia tools and field trips. Active participation in class discussions is expected.

Course Load

A minimum of 3 courses (12 units) is recommended, up to a maximum of 4 courses (16 units). Students may enrol in up to 4 courses or more, subject to availability.

Units & Contact Hours

2-unit course: 17 - 25 contact hours
4-unit course: 39 contact hours

Language of Instruction

English (students must demonstrate English proficiency)

Class Schedule

Classes are typically held on weeknights (6.30pm - 9.30pm) & Saturdays (9.00am - 5.00pm). Daytime electives are limited. A small number of intensive courses may also be offered.

Class Size

An average of 40 - 50 students per class.

Result Release & E-Transcript

An unofficial e-transcript can be generated 11 days after the following result release dates:

- Semester 1 (Fall): End of December
- Semester 2 (Spring): Early June
- Special Term (Summer): Mid-August

The official e-transcript will be sent directly to students approximately 2 months after the exchange semester.

Work Experience

Students from non-MBA master's programs are expected to have at least 2 years of post-graduate work experience.

MBA Buddy

Exchange students will be paired with an MBA Buddy to help them integrate into life at NUS and in Singapore.

Miscellaneous Student Fees (MSFs)

Exchange students are required to pay MSFs of approximately SGD 213.94, subject to annual revision.
